#### **SCHEDULE OF SPECIFIC COMMITMENTS AND RESERVATIONS**

##### **Explanatory note**

1. The present document contains the initial offer of the European Union in the context of TTIP negotiations. It includes a Schedule of specific commitments and reservations.
2. The EU offer lists reservations to both market access and national treatment at EU, national and – where appropriate - subnational level in Member States. This offer is made in the expectation that the US will offer a significant level of transparency at the sub-federal level.
3. The EU considers that the ambition of the EU offer is closely linked to the progress of discussions on regulatory cooperation. Therefore, commitments on financial services will be included at a later stage.
4. Given the unprecedented depth in market access and regulatory matters in TTIP, the EU has decided to undertake a thorough examination of the interface between measures relevant to the functioning of the internal market and the EU's present and future international obligations. This review may lead to some modifications or clarifications of the commitments included in the EU offer.
5. The EU maintains that the right to submit to a review (e.g. an authorisation and/or notification procedure) the direct or indirect acquisition and/or control of a company or firm or the establishment of a new company or firm in their respective territories on national security grounds, under existing or future legislation, will be preserved through exceptions in the TTIP text and consequently does not require specific reservations in the offer.

6. The European Union reserves the right to modify or withdraw this Schedule, in whole or in part at any time prior the conclusion of the negotiations. The European Union further reserves the right to make technical changes to this Schedule and to correct any errors, omissions or inaccuracies.
7. With regard to the format, the enclosed Schedule is based on TISA. It has been set out according to the core provisions adopted by TiSA participants at the occasion of the September 2013 round. References to the relevant articles of TISA are therefore included in this schedule for the purpose of clarification.
8. Subject to the outcome of discussions on Most Favoured Nation Treatment, Performance Requirements, and Senior Management and Board of Directors, relevant reservations can be listed subsequently.

#### **SCHEDULE OF SPECIFIC COMMITMENTS AND RESERVATIONS**

1. The specific commitments in this schedule apply only to the territories in which the Treaties establishing the European Union (EU) are applied and under the conditions laid down in these Treaties. These commitments apply only to the relations between the EU and its Member States on the one hand, and non-EU countries on the other. They do not affect the rights and obligations of Member States arising from EU law.
2. The rights and obligations arising from this Agreement, including the schedule of commitments, shall have no self-executing effect and thus confer no rights directly to individual natural persons or juridical persons.
3. In identifying individual sectors and sub-sectors, CPC means the Central Products Classification as set out in Statistical Office of the United Nations, Statistical Papers, Series M, N° 77, *CPC Prov*, 1991.
4. The list below does not include measures relating to qualification requirements and procedures, technical standards and licensing requirements and procedures when they do not constitute a market access or a national treatment limitation. Those measures (e.g. need to obtain a license, universal service obligations, need to obtain recognition of qualifications in regulated sectors, need to pass specific examinations, including language examinations, and non-discriminatory requirement that certain activities may not be carried out in environmental protected zones or areas of particular historic and artistic interest), even if not listed, apply in any case to services and services suppliers of other Parties.
5. Specific commitments for Market Access in Mode 1 (Cross-border supply) and Mode 2 (Consumption abroad) as specified in the EU's TISA offer of November 2013 (and subsequent revisions thereof) are included by reference into this schedule.
6. The EU takes commitments with respect to market access commitments as set out in Articles [ ] differentiated by its Member States, where applicable. The EU reserves the right to maintain or adopt any measure with respect to national treatment commitments as set out in Articles [ ], differentiated by its Member States, where applicable.
